- Giving my full attention and energy to my volunteer duties and to the girls while at the center
- Taking initiative to help out around the center and asking where I can be helpful
- Communicating clearly with staff regarding my needs and experiences as a volunteer
- Acting as a positive role model to girls through my attitudes, speech, and actions while at the center

As a volunteer for Girls Incorporated of Monroe County, I understand and agree with the organization's mission to inspire all girls to be strong, smart, and bold. I agree to treat the members as individuals and show respect toward each girl. I understand the importance of upholding a professional relationship with the members of Girls Inc, and agree to keep the relationships that I make with the girls within the hours I spend at the center.

During the volunteer orientation, I was informed that while working with the girls they might reveal personal information to me. I value each girl's right to privacy and understand that any disclosed information is not to be discussed with other members, or with persons outside of Girls Inc. I also agree to protect the confidentiality of each member by not sharing their identity or personal information to another social agency.

I know that as a volunteer of this organization and by state law, I am required to report any child who I suspect to be a victim of child abuse. A staff member will then take appropriate measure to report the case to Child Protective Services.
